# MEET ME AT THE Y WHERE FAMILY MOMENTS MATTER





Frank Ward remembers playing basketball in the late 60s at the North Attleboro YMCA on Elm Street. "It was the only organized sporting place to play ball for hours and hours. The Y was where all my friends were," recalls Frank.

Fast forward a few decades and the Y "on the hill" was the place where Frank's daughters Allison and Suzanne found their place. Both girls learned to swim at the Y. Allison was a gymnast, Suzanne played basketball and both were involved with the Teen Leaders program. Suzanne traveled to Prague in the Czech Republic in 2003 for a YMCA Youth Festival with her peers, Hockomock Y staff, and 4,500 teens from around the world.

Frank's relationship with the Y has come full circle. Recently retired, Frank makes the trip each Tuesday from his Centerville home with his wife Ann Marie to Foxboro to spend the day with their grandchildren David and Claire.

Frank and David enjoy taking sports class at the Invensys Foxboro Branch. "We come early to pass the ball around to warm up," says Frank fondly. "I enjoy it because I love sports and now I share that passion with my grandson."



"David is learning life skills at the Y that he'll carry with him throughout his life – just like I do and our family has," remarks Frank. "The Y is a safe place for families to gather and interact with others in the community. And it's a place for youth to gain confidence and develop." The duo's weekly ritual also includes socializing with David's classmates in the Kids Gym after class and making great friends. When "Bampi," as David calls his grandpa, asks him about his Y friends, David enthusiastically shares, "Charlie, Caleb, Oliver, and another David." Frank and David have also started swimming together at the Y.

When asked what Frank likes most about his time at the Y with David, he pauses, grins and shares with pride, "I love watching David smile and having fun."



# MEET ME AT THE Y WHERE SUPPORT BRINGS RESULTS

Liza Roach is a Y member with her daughter Mackenzie. Liza laughs, "We come to the Y more than anywhere else. My five year old daughter can give you directions to the Y from the back seat. This organization is a part of our daily life. It's family to us."

It was on one of those visits that Liza began talking with a staff member about the YMCA Diabetes Prevention program. Last May she started on her journey with the one year program.

"I've lost 25 pounds so far," shares Liza. "I'm 20 pounds away from being considered by my doctor for the brain surgery I need to mitigate my seizures, which means everything to me."

The YMCA Diabetes Prevention Program is designed to support adults that are at high risk of developing type 2 diabetes and reduce the risk. Consisting of 24 sessions, the program provides a welcoming environment for participants to work together in a small group to learn about healthier eating and increasing physical activity.





The power of the small group dynamic has given Liza the strength to keep going. "It's such a caring network. It's unique in that we're all different ages and we have diverse life experiences," remarks Liza.

Liza says it's the little changes she's making in her diet and exercise that are making a big difference. "I can still have the food I enjoy but in moderation. I'm counting fat grams every day. This is not a diet, it's a lifestyle change. And that's the difference for me." Liza has also found a love for yoga, an activity she was introduced to at the Y and enjoys for stress relief.

The Y is Liza's community. "I know more people now. I talk to more people now. I know their names and they know mine," Liza exclaims. "The Y is family. The Y is acceptance. The Y is making a difference in my life and I belong here."



# MEET ME AT THE Y WHERE VOLUNTEERS INSPIRE

Dan Cebrowski describes camp at the Hockomock Area YMCA as a tight knit community that is accepting of everyone. "This Y is truly a place of togetherness," remarks Dan who returned to the Y this past summer as a volunteer.

At camp, positive values and leadership traits are instilled in teens through service learning, team building, and adventure programming alongside their peers. Dan recalls the time last summer when the teens harvested the garden and created a vegetable stand in the lobby of the Y. They prepared the crops for sale, set prices, promoted the sale creatively, and interacted with people with proceeds benefiting the Y's annual support campaign.

Dan's mom signed up for a family membership at our Bernon Family Branch when he was 14. "The membership helped get me out of the house and active. I'd lift weights and use the track," added Dan, now 22. "People are always smiling at the Y and make me feel comfortable."

"What I loved most about my time volunteering at the Y was seeing the campers working together, building trust, and forming friendships," shares Dan. "To witness the teens' growth and maturity develop over time at camp was really special. This Y is truly a community that I've never experienced before."



# MEET ME AT THE Y WHERE ACCEPTANCE IS NURTURED

Adventures in Respect, our bullying prevention initiative, funded by the Honey Dew Family Foundation, has served 21,342 students since its inception in 2011 across our 15 community service area:

- 91% of the students surveyed revealed they had a better grasp on effective techniques to diffuse a bullying situation.
- 99% of respondents said the program was effective in helping them understand and accept the differences and similarities between themselves and others.
- 94% indicated they had seen their peers treat each other in a more positive manner based on the lessons and teachings of the program.

On Memorial Day Weekend, a cargo net with a 40-foot rope wall was dedicated to the memory of Marine Corps Captain Kyle Van De Giesen, a North Attleboro hometown hero who was killed in 2009 in combat in Afghanistan. This new challenge course element—Kyle's Climb—was constructed through a generous donation from the Capt. Kyle R. Van De Giesen Memorial Award Fund. Kyle was a YMCA youth and leader in the community, having climbed the Y ropes course countless times in his life. He was a young man who inspired so many and his legacy of honor, courage, and commitment will live on at the Hockomock Area YMCA through the Adventures in Respect initiative.





"We love working with the Y because the Y is so responsive. And the Y was Kyle's community," shares Kyle's mother Ruth Ann. "This program is impacting so many youth and teens in and around our community."

"We are proud that Kyle's legacy will continue to benefit all youth in our area and is a great way to honor Kyle," adds Kyle's dad Cal. "At camp last summer Colin walked by the leadership center sign with his buddies and nonchalantly said with a big smile, 'That's my dad.' He's so proud of it," reflects Kyle's widow Megan. "Colin and his sister Avery love camp and their Y and we are so proud they will grow up experiencing the Capt. Kyle Van De Giesen Outdoor Leadership Center and the Adventures in Respect program. It's so special to our family."
